Certificate of Origin Instructions

- **Item 1.** Exporter Enter the name and complete address of the company or person who is EXPORTING the good(s) detailed on the certificate.
- Item 2. Consignee Enter the name and complete address of the company or person who the detailed good(s) are CONSIGNED to.
- Item 3. Particulars of Transport Enter the particulars of transport. This should included the type of transport (ocean, air, road, rail etc.) along with any country specific requirements (transport permits, licenses etc.) the detailed good(s) may need to move to the country of destination.
- Marks and Numbers Enter any markings that are indicated on the shipping packages that the good(s) are contained in. Include ANY and ALL outside markings especially any specific handling instructions for the shipping packages or good(s).
- **Item 5.** Number and Kinds of Packages Enter the number of shipping packages along with the kind of shipping packages (crate, box, barrel etc.) the good(s) are packed in.
- **Item 6.** Gross Weight Enter the gross weight for the good(s) including the packaging and shipping containers.
- Item 7. Description of Goods Enter a complete description of the good(s) that the certificate covers. Be specific enough to allow authorities to determine the nature of the good(s). Each and every separate type of good(s) must be detailed on the certificate and must be described in such a way that a layman can determine the nature of the good(s).
- **Item 8.** Quantity For each described good(s) indicate the unit quantity of same.
- **Item 9.** Country of Origin For each described good(s) indicate the country of origin of same.
- *Item 10.* Declaration Enter the day, month and year the certificate was created. The signature of the person who completed the form must also be present.
- *Item 11.* Name of Authorized Trade Association Enter the name of the authorized trade association required by the country of export.
- Item 12. Country Certification Enter the country of origin of all good(s) stated on the certificate.
- **Item 13.** Place and Date Enter the date and place in which the certificate has been completed and signed.
